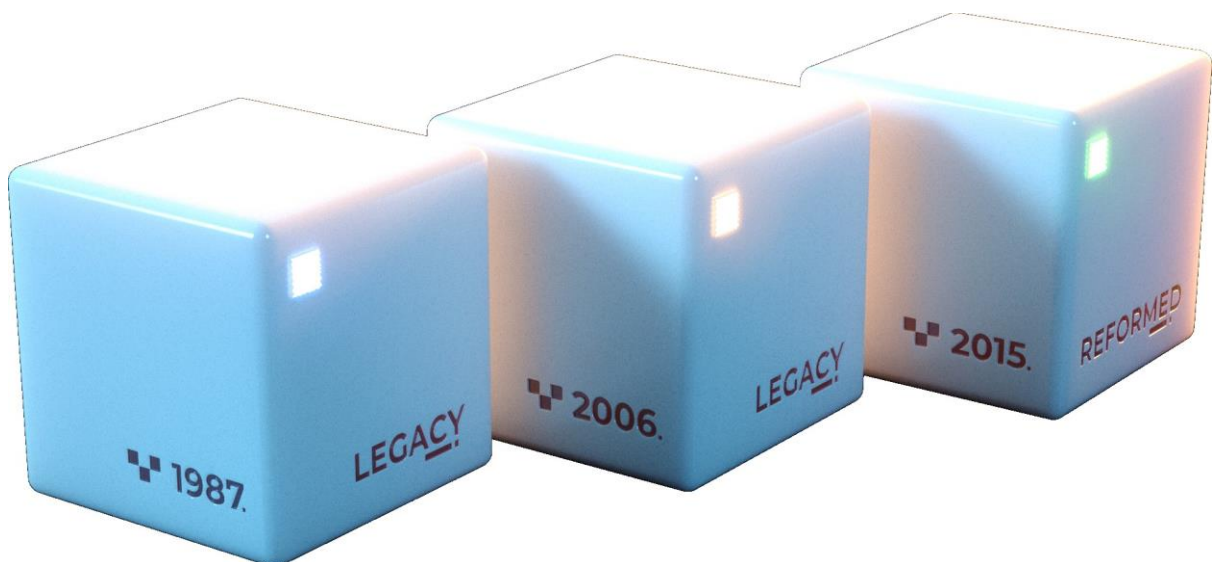

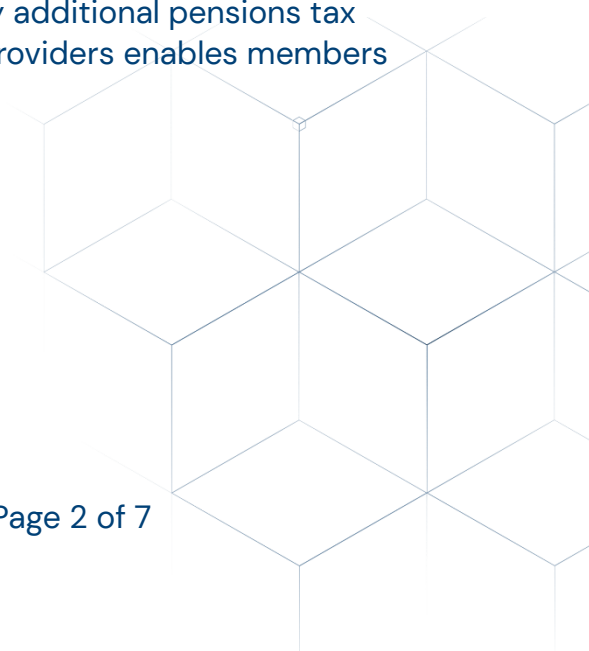

Purpose

1. The police staff associations have been asked to provide contact details of advisers, providers and services that they regularly work with.
2. This list represents those suggested providers which the staff associations have put forward. It is not an exhaustive list.
3. When members receive their remediable pension savings statements, they must use the HMRC digital service to calculate any additional pensions tax that they owe or are owed. This list of suggested providers enables members to seek professional help to use that service.

What information will I need to use the HMRC digital service?

Why would I need to access a suggested provider on this list?

5. If you are a member who needs to use the HMRC digital service to calculate your public service adjustment in relation to your pensions tax for the remedy period, you may wish to seek the help and support of a professional adviser to assure yourself that correct details have been submitted to HMRC.

Can I submit my own information into the digital calculator?

6. Yes, you do not need to use a professional adviser in order to submit your information to the digital service.

Do I have to use this list?

7. No, you can choose to use your own adviser if you have one, or you can choose from this list, or you can use the registered website of the Institute of Chartered Accountants England and Wales (ICAEW) to search for your own registered chartered accountant: – <https://www.icaew.com/about-icaew/find-a-chartered-accountant>.

Can I claim my costs back?

8. Yes if you meet the criteria in the [compensation guidance](#) and you need to pay for professional advice and support you can [submit a claim](#) to your scheme manager for your costs.
